### Evaluating implementation –

**Authority** – checks that public information form is received from operator following a facility designation as MHF. Note that security sensitive sites are excluded. Keep website up to date. Check compliance at regular inspections.

**Operator** - How does the authority evaluate that the implementation **by the operator** is effective? Compliance checked at regular inspections. Up to individual inspectors to decide what is acceptable, good practice is shared.

**Confidentiality** - All information held by WorkSafe is subject to Official Information Act and can be released following formal request. Operators are asked to mark any information as confidential if they believe it is. Before WorkSafe releases information to the public the operator is asked for comment and if they believe it is confidential to explain this. If it meets a reason to be withheld, it can be, but the principle is that information is made available unless there is good reason for withholding it. Decided on a case by case basis. Not required to disclose information that may lead to threat to security of the MHF.
